

# NORTHEAST HEIGHTS SELF STORAGE VEHICLE LOAN AGREEMENT

I / we \_\_\_\_\_ in consideration for my being allowed to use the vehicle identified above and the equipment listed on page 3 of this document for the sole purpose of moving my/our belongings into NEHSS do hereby indemnify, hold harmless, and release NEHSS, related entities, and its Partners, employees, owners and agents (collectively "NEHSS") from any and all liability whatsoever arising out of my / our use of such vehicle, and do hereby agree to hold NEHSS harmless and to defend them from any and all claims and liability whatsoever arising out of my/our use of the vehicle. I represent that:

- (a) I / we currently hold a valid drivers license which has not been restricted, suspended, revoked, or surrendered at any time, and I / we know of no impairment, of my / our driving ability that would cause me / us to not be able to operate the vehicle in a safe manner. (licensed)
- (b) I / we have current motor vehicle insurance coverage meeting the requirements of the New Mexico Mandatory Financial Responsibility Act and have provided NEHSS with a true and correct copy of insurance upon which the driver's name appears. (insured)
- (c) I / we are 21 years of age or older.

I / we also agree to forfeit the damage deposit plus pay any additional expense as necessary to apply to damage, repair / replacement costs, and the administrative costs associated with the repair process, including the vehicle lost time value, or any other amounts owed. I / we promise to pay NEHSS attorney's fees and other costs incurred by it in connection with my / our breach of any of the provisions of this agreement, or the use of borrowed items. If I / we damage or lose the vehicle or other property, I / we promise to pay NEHSS for the costs of repair or replacement within 24 hours.

I / we appoint NEHSS as my / our attorney in fact, to file claims and collect insurance proceeds and payments for any damage to any person, property or vehicles resulting from my / our use of NEHSS's truck. Occupant grants NEHSS a lien on property to be transported in NEHSS vehicles or placed in storage due to noncompliance with this agreement and/or failure to compensate NEHSS of all owed under this agreement.

**Initial Each of the Following Truck Rules:**

- \_\_\_\_\_ 1. One “free” use per unit – Only for transporting items to be stored in unit.
- \_\_\_\_\_ 2. Minimum gas charge of \$5.00 for the first 20 miles, \$.35 per mile thereafter.
- \_\_\_\_\_ 3. Truck can only be used within a 30 mile radius of the storage facility.
- \_\_\_\_\_ 4. Fasten and/or secure all property inside the truck.
- \_\_\_\_\_ 5. Exercise extreme care while backing up and changing lanes and avoid sharp swerving movements to avoid overturning or damaging the truck.
- \_\_\_\_\_ 6. Do not make any repairs and/or changes to the truck.
- \_\_\_\_\_ 7. Occupant is responsible for all parking summons with payment at time of truck “check-in”.
- \_\_\_\_\_ 8. Return the truck with all equipment to NEHSS (4801 Eubank NE, Albq, NM) in the same condition as at the time of rental.
- \_\_\_\_\_ 9. Occupant agrees to the following charges (where applicable) upon return of the truck:  
 \$5 for unfolded blankets, \$5 for not returning equipment to proper location in Truck,  
 \$5 for not sweeping out Truck, \$350 for each missing Appliance dolly,  
 \$8 for each missing tie down strap, \$75 for each missing 2-wheel hand-truck,  
 \$25 for each missing moving blanket, \$30 for missing jumper cables,  
 \$20 for missing emergency reflectors, \$10 missing broom, \$15 for missing ice scraper.  
 \*\*Other additional damage to the truck or NEHSS property costs be determined by the Manager/Contractor and cash deposit retained or credit card will be charged and unit will be secured until bill is paid.
- \_\_\_\_\_ 10. \$25 per hour or partial hour over-time charges. .
- \_\_\_\_\_ 11. Time allotments are as follows: Mon-Fri 9 – 1 or 2-6 Sat 9-1 or 1-5 Sun. 10 – 2. Truck must be empty, cleaned, parked and checked-in prior to the end of your time allotment or over-time fees will be charged.
- \_\_\_\_\_ 12. If you are using the Truck for additional times, moving out, etc. you are required to pay the **\$40 fee** per 4 hour time block and all gas charges, which will be deducted from your cash deposit or charged to your credit card account.
- \_\_\_\_\_ 13. *NO SMOKING IN TRUCK.*
- \_\_\_\_\_ 14. Forfeit of \$80 deposit for allowing drivers not listed as an authorized/insured driver on this agreement.

By your signature, you warrant that the information on the vehicle use and other drivers is accurate and complete. Further, you represent that you have read, and understand, and agree with the terms and conditions stated on this rental agreement.
